Terms and Conditions

Payment

A retainer of \$125 is required to reserve all Portrait Sessions. Full payment of all photographs must be received before they are ordered.

50% of the wedding package price is required to reserve Heavenly Moments Photography for your wedding date.

For the Milestones program, the registration fee is \$100 and each mini portrait session (of which there are five) is \$75.

Negatives / Digital Files

The negatives and digital files will remain property of Heavenly Moments Photography; however, they will be kept on file permanently for future re-ordering by the customer. Allow 4-6 weeks for processing time.

Exclusive Rights

For Wedding reservations, Heavenly Moments Photography is the exclusive official Photography Company hired to photograph the wedding.

Reservation of Rights and Copyright

We reserve the right to use any photographs in displays, contests, or publications (hard and soft copy), at any time, for company advertising and promotions. Heavenly Moments Photography will retain the copyright for all photographs taken.

Limitation of Liability

Utmost care is given to handling negatives, however, in the unlikely event that any or all negatives are ruined due to lab or other unforeseen equipment complications, Heavenly Moments Photography will be liable to refund only one hundred percent of the deposits paid.

Cancellations

In the event of a customer cancellation of a portrait, family, or graduation sitting, 50% of the retainer paid to Heavenly Moments Photography will be refunded to the customer, provided the cancellation is at least 7 days before the reserved Portrait Session. We understand unforeseen circumstances, and as such, it is possible to reschedule your Portrait Session up to 24 hours prior without penalty. However, as we reserve the time slot specifically for you, if you do not come for your Portrait Session or are more than 1/2 hour late, your retainer will not be refunded.

In the event of a cancellation or postponement of a reserved wedding date by the customer, any deposits paid by the customer will be refunded by HMP to the customer, provided the cancellation is given a minimum of 60 days prior to the scheduled wedding date. Otherwise a wedding deposit is non-refundable.
